

## **TOWN OF TROCHU – RESIDENTIAL/BUSINESS LOT SALE REFERRAL POLICY**

**POLICY No. – 2021-01-25-01**

**POLICY NAME: Residential/Business Lot Sale Referral Policy**

**I. HISTORY:**

The Town of Trochu in an effort to encourage people and businesses to locate in Trochu has explored and adopted various Economic Development Policies. Current policies contain no incentives to encourage current residents/visitors/business owners to promote Trochu. As society and technology changes, businesses and individuals recognize there is a reduced need to be located in the city. Rural communities are entering a golden age of opportunity as this shift becomes more evident. To maximize this opportunity, a policy is needed that encourages people/businesses that know and love Trochu to promote it.

**II. PURPOSE:**

This policy will implement a program that will reward people/businesses with a monetary incentive for promoting Trochu to their friends/family/colleagues. The goal of this policy is to increase sales of residential and business lots owned by The Town of Trochu. This increase in sales will lead to new businesses and homes being built in Trochu, strengthening the community and its viability.

**III. TERMS of this POLICY:**

As this is a pilot project the term will be January 1<sup>st</sup>, 2021 to December 31, 2021. If successful it may be incorporated into the Economic Development Policy.

**IV. POLICY GUIDELINES:**

- 1) \$1,000.00 Referral Bonus
  - a) An individual who successfully refers a person/business to purchase a Town of Trochu residential/business lot is eligible to receive a \$1000.00 paid by Cheque or EFT
  - b) This is an optional incentive program; no referral is required to purchase a lot from The Town of Trochu
  - c) The policy only applies to Town of Trochu owned lots – residential or business
  - d) \$1000.00 payable by cheque or EFT 60 days after the sale is finalized and lot payment has been received in full



**Appendix A**

**Referral Bonus Document**

The Town of Trochu offers \$1000.00 Referral Bonus paid by Cash or EFT after the successful sale of a Town owned lot. Payment of the Referral Bonus will be paid to the person named below within 60 days after full payment of the lot sale has been received from the purchaser by The Town of Trochu.

- g) Only one person can be named on the Referral Bonus Document




