- a) Electric vehicle charging stations
 - -Council discussed installing electric vehicle chargers in town
 - -previous quote for installation was approx. \$95,000, Dave will contact ATCO for any updates on cost and installation options
- b) Antique farm machinery displays
 - -Council directed staff to request antique machinery donations to be used as displays around town, suggested giving displays concrete bases for ease of maintenance
- c) MOST Funding
 - -Jaime discussed options for using surplus MOST funding
 - -Council supported the option to give the surplus funding to local community groups that work out of facilities and whose funding was affected by the COVID pandemic.
 - -Council directed staff to bring a Request for Decision regarding this to the next regular Council meeting

d) Capital Projects

- -Dave presented updates to the 2021 Capital Projects list, including additional sidewalk grinding/repairs
- -Councillor Reed suggested purchasing a grinder for Town use rather than hiring a contractor, Dave will look into options
- -dredging of lagoon cells and installation of remote water readers are high priority items
- -discussed allocation of funds to the projects
- -discussed possibility of yearly allocation for street repairs

e) MPE - Koch Subdivision

- -Carl spoke with Greg Sentis regarding servicing of the Northwest ASP, possibly starting with laying out survey pins in late 2021 or early 2022
- -Greg suggested a preliminary meeting with Council, Sam Smalldon, and Sexsmith Surveys, possibly between March $15^{\rm th}$ to $19^{\rm th}$
