### 3. DELEGATIONS

- a) 6:10pm, Alberta Municipalities Energy Management Services (Alberta Municipalities representatives Kyle Kasawski and Sandra Durante, and Trane representative Darryl Hill)

  - report included analysis of utility costs, possible retrofit opportunities, and potential resulting savings
  - discussed the next step, which would be a more in-depth Investment Grade Audit
  - will be making a similar presentation to the Kneehill Regional Partnership committee soon where they will also discuss possible savings if more than one local municipality participates

- b) Municipal Planning Commission Bylaw Draft
  - Carl Peterson presented the draft and reported that it had been previously reviewed by Palliser and the current MPC
  - Bylaw will be brought forward to next regular Council meeting
- c) Lotto Policy Draft
  - Carl Peterson presented the draft
  - Policy will be brought forward to next regular Council meeting

## d) Potential dog show

- Organizers of a dog show have contacted the Town regarding renting the campground facilities (Bruce Guard Centre, ball diamonds, and all campsites) for the show which is to be held from May 13 to 15, 2022
- Dave Nelson discussed our current fees and Council proposed a fee of \$500/day for the Bruce Guard Centre and ball diamonds plus regular camping fees for attendees

## e) Policing model discussion

- Discussed a webinar coming up on Wednesday the 19<sup>th</sup>, several Councillors have registered to attend
- Also discussed an invitation to join the Alberta Association of Police Governance

# f) Extended Producer Responsibility engagement survey

# g) Town Realtor

- Carl reported that the Town Realtor contract is coming to an end on January 31st
- New contract will be brought forward to next regular Council meeting

# h) Trochu & District Agricultural Society

- The Ag Society is requesting sponsorships for their annual Rodeo Weekend in June
- Request will be brought forward to next regular Council meeting

## i) Campground

- Discussed Campground Manager Darrel Stewart's recommendations for the upcoming camping season
- Recommendations included a small playground, token-operated showers, more picnic tables, and main gate access control

### j) Land Use Bylaw discussion

- Councillor Reeds discussed possible changes and additions to the Land Use Bylaw
- Suggestions included guaranteeing access on adjacent lots for commercial developments on properties with zero-lot-line setbacks, and reviewing residential frontage and setback requirements for consistency and feasibility
