#### b. Communities in Bloom

They are going to be working on a few smaller projects and projects that were previously put on hold due to a lack of funds. They will also be continually working on their strategic plan that was put on hold in 2009. One of their projects will be to work with youth to discuss the watershed and how what we put down our drains ends up in our drinking water. They have made a commitment to pledge \$5,000.00 for the ACE Trail System. There is also a commitment to work with the Town to replant and replenish the trees that were damaged in last year's storm. Work with the Centennial Committee will consist of flag displays throughout the town, a possibly floral display at the centre of Arena Avenue and Main Street, and "100 Trees for 100 Years" which will be a new tree nursery located at the Trochu Public Cemetery.

#### c. ACE

They are having continual meetings for the three priority projects and are glad to hear that Council is up to date with what is going on with each of the committees. There is also now a youth writer who will be doing a Trochu blog for the ACE blog site.

#### B. REPORTS OF COUNCIL MEMBERS

#### **Councillor Cunningham**

Stewart Maclean was very entertaining.

Kneehill Housing is going ahead with an addition onto Golden Hills Lodge to increase the office space and meeting room. They had a renovation on the Robertson Manor and things came in under budget. Golden Hills will be celebrating 50 years in September. Trochu Valley Manor is still in the black and there are four vacancies.

At the School Resource Officer meeting Amanda said that she is done at the end of June and they are advertising for her position. She has also found a new position in Calgary. They would like the new individual in place so that they can have her train them. The Society By-laws have been circulated and will be voted on at the next meeting. There may be a possibility of a Sportsman's Dinner fundraiser.

Centennial Committee had a good turnout at the last meeting. They have a good list of events that may occur and have had some discussion concerning the grant. There is money available for a capital item and it was brought up that a statue of Armand Trochu may be an idea.

Community Reach was a lot of run.

#### **Councillor Hollidge**

Attended the Leadership Supper about Bullying in the Workplace. The turnout was very good and the information was very interesting.

At Community Reach thought the Council team did a really good job even if they came in second place.

#### Councillor Nelson

Attended an FCSS meeting and would like to remind everyone that Volunteer Week starts April 18' 2010. The West Central meeting is going to be in Trochu at the Hall on May 12, 2010 and the alternates are invited to attend. Senior's Outreach is having a supper on April 15<sup>th</sup> for their anniversary. So far there have been 40 tax returns completed through the tax return program. There is now a new director at the government level.

#### **Councillor Reeds**

Attended a Red Deer River Municipal Users Group Meeting. Alix has a hot water tank replacement program where residents get a \$50.0 0 rebate to replace an old tank. There is also a device that can be installed in an older toilet that can turn your toilet into a dual flush toilet. Someone from AB environment gave a presentation about pulling gravel from the river bed and how it diminishes the water storage so it is only allowed in small operations.

## **Councillor Wagstaff**

Thought that the local band who played at the Lion's cabaret was very good.

## **Deputy Mayor Helmer**

Took part in Community Reach.

# Mayor Barry Kletke

Went to the aamdc convention in Edmonton. They had a lot of big name speakers: The Health Minister talked about what is happening in Health Care. They have approved a new budget with five year funding plan that is stable and will increase over the next five year concentrating on when, where and how to provide health care. They have also wiped out the deficit that was left by the old board.

The Alberta Rural Physician Action Plan is going forward and will be adding more residency positions. They have halted looking at centralized dispatch for EMS calls. On March 31, 2010 they will announce their long term capital plan and will be coming to visit St. Mary's shortly after.

Jack Hayden talked about how we need to work harder to start exporting to countries other than the US, mainly China and how they are trying to build new relationships between different countries. They are already moving to declare a drought for pastures with the federal government. As well, grasshoppers will be a problem this year because last fall had the perfect conditions for laying eggs. The conditions right now are some of the driest on record and we are on the very edge of this; it gets worse as you move both North and East of Trochu. The number one priority is on primary producers. Insurance rates should be decreasing and last year alone \$3,000,000.00 more was paid out than came in on the insurance program. Luke Oullet let everyone know that there were no 2010 projects cancelled in his ministry. They will be spending 1.9 million on highways. They are also lobbying the federal government to potentially allow different rail companies use existing lines.

The Modular Manufactured Housing Association attended the Trade Show. They also build apartment complexes at very reasonable prices. The informed us that a Bylaw can be approved that only allows modular homes that look like stick built homes. As well, there are many communities in Saskatchewan who are doing the same type of projects and are making money off of the sales of these homes so it is very cost efficient. There is a 60 to 90 day delivery period. Mayor Kletke would like Council to invite the association to make a presentation about modular housing.

Met with assessor and Maureen about residential and commercial assessments. It is not quite as easy to cahnge things as we would like. We did get our eyes opened on some of the resale of properties in town and so we should start to see an increase. We need to find a way to help people realize that they shouldn't look at just the mill rate when looking at building in Trochu but actually what the assessment and mill rate are together because this is what actually makes the taxes and that our taxes are actually very competitive.
