Community Futures was cancelled this month. At the next meeting she will be asking if we can possibly get a loan to help build low income housing or if we create a foundation for this project will they donate to it.

Junior Achievement is looking for business sponsors for their golf tournament, these include door prizes, food sponsorship, etc.

#### **Deputy Mayor Helmer**

Attended the Home Show in Red Deer. There were about ten communities that had booths there trying to "sell" their towns as a place to live and invest. We should look at doing this next year as well as attending Calgary's Home Show.

Had a discussion with some Three Hills residents concerning ATCO water. It became clear that they didn't really understand what was going on based on what they have been told by the Town of Three Hills. What we need to let people know is that we are doing this to save their water treatment plant not to get rid of it. The plant needs many upgrades and there is nothing stopping the Provincial Government from shutting it down because they don't want to fund these upgrades. If ATCO Water is involved then they will be funding the upgrades and the Provincial Government will not be able to shut it down for that reason. Also, the Provincial Government has made it clear that they will not give us funding to join the Kneehill Water Partnership so this is not an option.

# Mayor Barry Kletke

Has been put in contact with a gentleman who is building housing complexes for communities in the Edmonton region. He has told us that there is grant money available for these types of projects and discussed options for building. Would it be worth purchasing a set of blue prints for a building and putting out a request for proposal in order to get some feelers out there and see what a project of this type would cost us. Housing is definitely a problem in this community and we need to come up with something to deal with it.

Attended a Clean Technologies Conference in Calgary. There are lots of Canadian Businesses that have great ideas but cannot sell them to Canadians so instead of gone global. As well, the regulations put in place by the Government are very stringent. The Windmill Farm in Paint Earth County is going ahead.

Saw some of the imedia tv videos that communities have purchased through CAEP at the CAEP Marketing Meeting. Because of how long it took to make each video we have been given more time for free. As well, it will only cost an extra \$250.00 for each additional 30 second piece that we would like to add which would include shots that were taken but were not used for the current video. We may also want to look into updating the video in the future with things like that Tee and podium as well as more footage of our recreational facilities.
